- Mitigation hierarchy: avoid, minimize, mitigate
- Landscape-level conservation
- Regulatory certainty for land users
- Value for habitat and preservation
- Metrics: quantification of impacts and benefits
- Additionality
- Net benefit





USES OF COMPENSATORY MITIGATION

- BLM Desert Renewable Energy Conservation Plan
- WAFWA Range-Wide Conservation
 Plan for the Lesser Prairie-Chicken
- Barrick Gold Nevada Sage-Grouse Bank Enabling Agreement





BLM COMPENSATORY MITIGATION

- BLM greater sage-grouse land use plans
 - BLM will "require and ensure mitigation" that provides a net conservation gain when authorizing actions that result in habitat loss and degradation
 - Regional mitigation strategy to be established by September 2016
 - Final Regional Mitigation Manual MS-1794 forthcoming

 Conserving Greater Sage-Grouse Habitat
- Montana Executive Order No. 10-2014 and Greater Sage-Grouse Stewardship Act
- Nevada Greater Sage-Grouse Conservation

- Oregon Mitigation Framework and Mitigation Rules



MITIGATION MECHANISMS

- Permittee-responsible mitigation
- In lieu fee
- Mitigation banks
- Mitigation credit-trading programs
- Hybrid approaches









ISSUES ASSOCIATED WITH MITIGATION

- What is the appropriate mitigation mechanism?
- Who administers the compensatory mitigation program?
- What metrics are used? How are metrics consistent between programs?
- How is the price of credits determined?
- What is the scope of the program—project, state-wide, habitat region, or range-wide?
- What is the role of stakeholders?
- What regulatory certainty is provided?



WHAT TO EXPECT NEXT?

- Lack of federal guidance through early-2016
- Competition to establish mitigation mechanisms
- Coordination among states and federal agencies regarding mitigation principles
- Mitigation required for federal projects
- Mitigation required for non-federal projects?
